RESOLUTION RECOMMENDING TO THE HEAD OF PROCURING ENTITY (HOPE) OF PHILIPPINE STATISTICS AUTHORITY-X THE AWARD OF CONTRACT TO MALASAG RESORT CORPORATION WITH A CONTRACT PRICE OF FOUR HUNDRED SEVENTY-TWO THOUSAND SIX HUNDRED SEVENTY PESOS ONLY (PHP472,670.00) FOR THE PROCUREMENT OF LEASE OF VENUE WITH MEALS AND ACCOMMODATION FOR THE 2024 FUNCTIONAL LITERACY, EDUCATION AND MASS MEDIA SURVEY DATA EVALUATION WORKSHOP

**WHEREAS**, Regional Director Dr. Janith C. Aves as Head of the Procuring Entity (HOPE), approved the 2025 Annual Procurement Plan (APP) – 1<sup>ST</sup> Update of the Philippine Statistics Authority-Regional Statistical Services Office X;

**WHEREAS**, included in the 2025 APP – 1<sup>st</sup> Update is the Procurement of Lease of Venue with Meals and Accommodation for the 2024 Functional Literacy, Education and Mass Media Survey Data Evaluation Workshop;

WHEREAS, the Procurement of Lease of Venue with Meals and Accommodation for the 2024 Functional Literacy, Education and Mass Media Survey Data Evaluation Workshop has an Approved Budget for the Contract (ABC) of Five Hundred Seventy-Two Thousand Nine Hundred Fifty Pesos Only (PhP572,950.00);

**WHEREAS**, on 25 February 2025 the PSA-RSSO X through its Regional Office Bids and Awards Committee (ROBAC) simultaneously invited suppliers to participate in the said procurement, namely: (a) Bonne Business Corporation; (b) Apple Tree Resort & Hotel; and (c) Malasag Resort Corporation;

**WHEREAS**, the three interested suppliers passed the eligibility screening conducted by the PSA-RSSO X Technical Working Group (TWG) on 28 February 2025;

**WHEREAS**, price offers were evaluated by the PSA-RSSO X TWG with the results indicated in the Abstract of Quotation (copy hereto attached as **Annex A**) with the quotation of Malasag Resort Corporation evaluated as the lowest calculated quotation;

**WHEREAS**, the PSA-RSSO X TWG proceeded with the evaluation of the proposal of the suppliers in terms of their compliance to the specifications with Malasag Resort Corporation found to have the rating of 91.3 percent;

WHEREAS, after careful examination by the PSA-RSSO X TWG of the documents of the supplier and the specifications of their proposal, Malasag Resort Corporation with a price quotation amounting to Four Hundred Seventy-Two Thousand Six Hundred Seventy Pesos Only (PhP472,670.00), inclusive of all government taxes and fees, which is within the ABC, rendered as the highest rated responsive bidder of 95.7 percent as indicated in the evaluation summary;
