RESOLUTION RECOMMENDING TO THE HEAD OF PROCURING ENTITY (HOPE) OF PHILIPPINE STATISTICS AUTHORITY-X THE AWARD OF CONTRACT TO STRAWHATS PRINTING AND DESIGN FOR ITEM NO. 1 WITH A CONTRACT PRICE OF THIRTY-EIGHT THOUSAND FIVE HUNDRED NINETY-TWO PESOS ONLY (PHP38,592.00) AND UNITED CMYK DIGITAL PRINTING CORPORATION FOR ITEM NO. 2 WITH A CONTRACT PRICE OF FORTY-FIVE THOUSAND SIX HUNDRED PESOS ONLY (PHP45,600.00) FOR THE PROCUREMENT OF OPERATIONAL KIT MATERIALS FOR EA DELINEATION FOR THE DEVELOPMENT OF CBMS/POPCEN EARF, SUBJECT TO APPLICABLE RULES AND REGULATIONS

WHEREAS, Regional Officer-in-Charge Dr. Janith C. Aves as Head of the Procuring Entity (HOPE), approved the 2024 Annual Procurement Plan (APP) – 1st Update of the Philippine Statistics Authority-Regional Statistical Services Office X;

WHEREAS, included in the 2024 APP – 1st Update is the Procurement of Operational Kit Materials for EA Delineation for the Development of CBMS/POPCEN EARF;

WHEREAS, the Procurement of Operational Kit Materials for EA Delineation for the Development of CBMS/POPCEN EARF has an Approved Budget for the Contract (ABC) of One Hundred Sixty-Eight Thousand Six Hundred Pesos Only (PhP168,600.00);

WHEREAS, on 07 February 2024, the PSA-RSSO X through its Regional Office Bids and Awards Committee (ROBAC) posted the request for quotation in the PhilGEPS and simultaneously invited suppliers to participate in the said procurement, namely: (a) Strawhats Printing and Design; (b) PL Ink Supplies and Printing Station; and (c) Solar Ace Premium Products Incorporated; (d) United CMYK Digital Printing Corporation; (e) MLG Advertising;

WHEREAS, the PSA-RSSO X TWG conducted the Opening and Evaluation of Price Quotations on 14 February 2024 with the results indicated in the Abstract of Quotation (copy hereto attached as **Annex A**) with the quotation of the following suppliers found to have the lowest calculated quotation for all lots;
