## **RESOLUTION NO. 213**

RESOLUTION DECLARING THE BID OF MARCOMMAX ENTERPRISES AS THE LOWEST CALCULATED RESPONSIVE BID FOR LOTS 1, 2, AND 3 IN THE SUPPLY OF MATERIALS AS TOKENS FOR THE CENSUS-COORDINATING BOARD (CCB) MEMBERS FOR THE 2024 CENSUS OF POPULATION-COMMUNITY-BASED MONITORING SYSTEM (2024 POPCEN-CBMS) BIDDING NO. 2024-03 AND RECOMMENDING TO THE HEAD OF PROCURING ENTITY (HOPE) OF THE PHILIPPINE STATISTICS AUTHORITY-X (PSA-X) THE AWARD OF CONTRACT TO MARCOMMAX ENTERPRISES FOR LOTS 1, 2, AND 3

WHEREAS, the Regional Office Bids and Awards Committee (ROBAC), with the assistance of the TWG, conducted a first round of post-qualification on 09 September 2024, 9:30 AM, and second round of post-qualification on the same day at 5:00 PM with Marcommax Enterprises for Lots 1, 2, and 3 of the Supply of Materials as Tokens for the Census-Coordinating Board (CCB) Members for the 2024 Census of Population-Community-Based Monitoring System (2024 POPCEN-CBMS) PB No. 2023-03;

WHEREAS, the following observations occurred during the Post-Qualification for Marcommax Enterprises for Lots 1, 2, and 3:

- Verified, validated and ascertained the authenticity of the Eligibility Documents through
   the bidder's presentation of original copies; and
- The bidder was granted a 1-day extension for the presentation of another sample for Lot 2 in accordance to its required specifications preferred by the end-user.
- WHEREAS, on 10 September 2024, the Regional Office Bids and Awards Committee, together with the TWG, convened for the third round of post-qualification for Lot 2 presented by Marcommax Enterprises:
- WHEREAS, the Customized Foldable Fan with Pouch for Lot 2 has been found to conform to the technical specifications. These observations were documented in the Post-Qualification Report of the TWG (attached as Annex A).
- WHEREAS, on 11 and 12 September 2024, the TWG conducted further verification of the documents submitted by Marcommax Enterprises regarding the single largest and ongoing contracts with the concerned agencies.
- NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to declare the bid of Marcommax Enterprises as the Lowest Calculated Responsive Bid for Lots 1, 2, and 3:
- of Contract for Lots 1, 2, and 3 in the Supply of Materials as Tokens for the Census-Coordinating Board (CCB) Members for the 2024 Census of Population-Community-Based Monitoring System (2024 POPCEN-CBMS) PB No. 2024-03 to Marcommax Enterprises with a contract amount of Eight Hundred Twenty-Eight Thousand Five Hundred Fifty Pesos Only (PhP828,550.00).
