## INVITATION TO BID FOR THE PROCUREMENT OF JANITORIAL SERVICES FOR THE PHILIPPINE STATISTICS AUTHORITY-X (PSA-X) FIELD OFFICES FROM 01 April 2025 TO 31 DECEMBER 2025

1. The *Philippine Statistics Authority-X (PSA-X)*, through the *National Expenditure Program FY 2025* intends to apply the sum of *One Million Two Hundred Twenty Five Thousand Three Hundred Sixty Five Pesos and 77/100 Only (PhP 1,225,365.77)* being the total Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

- 2. The *PSA-X* now invites bids for the above Procurement Project. Delivery of the Goods is required by *01 April to 31 December 2025*. Bidders should have completed, within *three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB; provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.

6. The *PSA-X ROBAC* will hold a Pre-Bid Conference which shall be open to prospective bidders on *14 February 2025*, *8:30AM* at the PSA-X Conference Room of the above-

mentioned address. The PSA-RSSO X can accommodate a maximum of **two** representatives per prospect bidder to participate.

- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated above on or before *26 February 2025*, *12:00 Noon*. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on 26 *February* 2025, 1:30 P.M. at the above-mentioned address. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity. A maximum of one bidder representative can be accommodated onsite to maintain social distancing at the PSA-X Conference Room.
- 10. The *PSA-X* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
