



Since none of the bidders whose 1<sup>st</sup> envelope (Eligibility Documents and Technical Requirements) was rated passed, no 2<sup>nd</sup> envelope (Financial Proposal) was opened by the BAC. This is pursuant to section 30.2, 1<sup>st</sup> paragraph, of the IRR of RA 9184 where it expressly provides,

"Immediately after determining compliance with the requirements in the first envelope, the BAC shall forthwith open the second bid envelope of each remaining eligible bidder whose first bid envelope was rated "passed." The second envelope of each complying bidder shall be opened within the same day, except as provided under Section 33 of this IRR. In case any of the requirements in the second envelope of a particular bid is missing, incomplete or patently insufficient, and/or if the submitted total bid price exceeds the ABC, the BAC shall rate the bid concerned as "failed." Only bids that are determined to contain all the bid requirements for both components shall be rated "passed" and shall immediately be considered for evaluation and comparison."
