After the deliberation of the submitted requirements for eligibility checking, LCD VISA Manpower Services was declared FAILED by the ROBAC for the technical documents.

The ROBAC, through Mr. Neil Lester A. Gimeno, informed the bidder for additional reminders and mentioned that a bidder that was absent during the opening of the bids and was found ineligible or was declared failed has three (3) calendar days from receipt of the Notice of Ineligibility/Failure, within which to file a written request for reconsideration before the BAC. If the bidder was present during bid opening and was duly notified (a verbal notification will suffice in this case) of its ineligibility/failure, it also has three (3) calendar days upon such notice within which to file a written request for reconsideration. Seven (7) calendar days after it receives a letter requesting for reconsideration, the BAC should resolve such request.

Having no other matters to discuss, the Opening of Bids adjourned at 3:03PM.
