Eligibility Criteria

- Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.
- ➢ Bidders should have completed, within the last three (3) years (earliest project: 22 August 2020) from the date of submission and receipt of bids, a contract similar to the Project. Contract similar to the project is procurement of supplies and materials (goods).
- ➤ The Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA's CPI, must be at least equivalent to at least fifty percent (50%) of the ABC.







Eligibility Criteria

- > The NFCC must be sufficient for the total of the ABCs for all the lots or items participated in by the prospective Bidder (equal to the ABC of the lots to be bid).
- For bidders submitting the committed Line of Credit, it must be at least equal to ten percent (10%) of the ABCs for all the lots or items participated in by the prospective Bidder.

Subcontracts

> Subcontracting is not allowed.

Clarification and Amendment of Bid Document

Clarifications must be in writing and received at the PE's address or via email, at least ten (10) calendar days (12 August 2023) before the deadline set for the submission and receipt of bids.

Statement of the bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid, except under conditions provided for in Sections 23.4.1.3 and 23.4.2.4 of the 2016 revised IRR of RA No. 9184, within the relevant period (earliest project: 17 July 2020) as provided in the Bidding Documents; and
- i. Original copy of Bid Security. If in the form of a Surety Bond, submit also a certification issued by the Insurance Commission;

Technical Component of the Bid

The Supplier's audited financial statements, showing, among others, the Supplier's total and current assets and liabilities, stamped "received" by the BIR or its duly accredited and authorized institutions, for the preceding calendar year which should not be earlier than two (2) years (earliest audited FS: year 2020) from the date of bid submission; and
- m. The prospective bidder's computation of Net Financial Contracting Capacity (NFCC);
 (values in the computation must be consistent with the audited FS)
 or

A committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation.

➤ All documents that form part of the Technical bid shall be enclosed in one envelope and duly marked as "TECHNICAL COMPONENT".







Financial Component of the Bid

➤ The Bid and bid security shall be valid until 18 December 2023 from the date of opening of bids. Any Bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive





Sealing and Marking of Bids

➤ Each Bidder shall submit <u>one envelope</u> containing two sub-envelopes bearing the original copies of the first and second components of its Bid. The sub-envelopes must also be duly marked "TECHNICAL COMPONENT" and "FINANCIAL COMPONENT". In addition, aside the label, write-in the name of the company for proper identification of the documents.

Bid Evaluation

- > Partial bid is not allowed.
- ➤ The Procuring ROBAC shall immediately conduct a detailed evaluation of all Bids rated "passed," using non-discretionary pass/fail criteria. In case of clarifications of the submitted bid, the ROBAC, through the Secretariat, will ask the bidder in **writing**. All responses to clarification shall be in writing.

Instruction to Bidders







Post-Qualification

➤ Within a non-extendible period of five (5) calendar days from receipt by the Bidder of the notice from the BAC that it submitted the Lowest Calculated Bid, the Bidder shall submit its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS)







Performance Security

➤ Within ten (10) calendar days from receipt of the Notice of Award by the Bidder from the Procuring Entity but in no case later than prior to the signing of the Contract by both parties, the successful Bidder shall furnish the performance security in any of the forms prescribed in Section 39 of the 2016 revised IRR of RA No. 9184, which states that the amount of the performance bond is equivalent to five percent (5%) of the contract price in the form of cash or cashier's/manager's check issued by a universal or commercial bank; Five percent (5%) in the form of bank draft/guarantee or irrevocable letter of credit issued by a universal or commercial bank, provided that it shall be confirmed or authenticated by a local bank, if issued by a foreign bank; or thirty percent (30%) of the contract price if in the form of surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security, and in no case later than the signing of the contract.

Inspection and Tests

➤ The Procuring Entity or its representative shall have the right to inspect and/or to test the Goods to confirm their conformity to the Project specifications at no extra cost to the Procuring Entity in accordance with the Generic Procurement Manual.
